## **Rental Agreement & Acknowledgement of Risk**

I, the Lessee, understand and acknowledge that the rental and use of this inflatable unit(s) brings with it both known and unanticipated risks to myself and my guests. Those risks include but are not limited to possible personal property damage, possible injury or possible death to myself or my guests.

I, the Lessee, do voluntarily release, indemnify, hold harmless and discharge Brady's Bounces from any and all liability claims, demands, actions or rights of actions whether personal to me or to a third party which are related to arise out of or in any way connected with me renting an inflatable unit(s) or to those allegedly attributable to neglect acts or omissions. I agree to reimburse any attorney fees and costs which may be incurred by Brady's Bouncers in the defense of any such liability claim, demand, action or right of action. In the event that I file a lawsuit against Brady's Bouncers, I agree that the substantive law of the state may apply in the action without regard to the conflict of the law of the state.

I, the Lessee, acknowledge having adequate homeowners' insurance, tenants insurance, or other liability insurance to cover any bodily injury or property damage which may occur to me and/or my guests for the use of the unit(s) being rented.

I, the Lessee agree to as needed, Fix or Repair (up to replacing the unit) any damage done to the unit being used/rented due to neglect, misuse, abuse and damage caused by your pets and any animals in your yard or business.

I, the Lessee, agree to supervise both the equipment and its use at all times while the equipment is in my possession. I knowingly and freely assume all the risks, both known and unknown, even if arising from negligence of others and assume responsibility for the actions of all my guests. Accompanying the contract is a set of Safety Rules and Regulations which I have read and agree to follow and utilize at all times during the operation and use of the inflatable unit(s).

I, the Lessee, acknowledge and certify that I have had sufficient opportunity to read this entire document. I understand its content and I execute it freely, intelligently and without duress of any kind and agree to be bound by its items/terms .

## Safety Rules and Regulations

1. Participants using the inflatable unit should be sorted by size and age to prevent injury. Only 8 participants inside the inflatable at a time. Do not exceed the inflatable max weight of 1000 lbs.
2. All participants must remove shoes, glasses, jewelry, belts and any other sharp objects that may puncture the inflatable unit or cause harm to themselves or other participants.
3. There shall be no flipping, no climbing or hanging on the netting and no rough play inside the inflatable unit.
4. No chewing gum nor food or drink of any kind shall be allowed inside the inflatable unit.
5. No toys, party favors, confetti, glitter or silly string shall be allowed inside the inflatable unit.
6. Do not tape or fasten anything to the inflatable unit.
7. This inflatable unit is not designed to be a water ride, do not get it wet.
8. Do not allow participants behind the inflatable unit in order to avoid contact with the blower and electrical cords that could cause the loss of power and deflation of the inflatable unit.
9. If winds exceed 15 mph, all participants must be removed from the inflatable unit for their safety.
10. **PLEASE**, it is very important that participants be supervised at **ALL** times while inside the inflatable unit to ensure their safety.
11. Please review these rules with all guests that will be using the inflatable unit.

### **If the inflatable unit begins to deflate:**

1. Immediately remove all participants from the inflatable unit; climb on top of the inflatable unit and use the Velcro roof-top exit to remove participants if roof collapses down.
2. If the blower has stopped running: Check the cord connection at the outlet and make sure the blower is switched to the ON position. Check your homes circuit breaker next.
3. If the blower is still running: Check that the inflatable tube has not become twisted causing diminished air flow or has been pulled loose from the blower causing air to escape.

### **If in-climate weather occurs: (Rain, Thunder, Lightning or Winds in excess of 15 mph)**

1. Immediately remove all participants from the inflatable unit.
2. Turn blower to OFF position, allow inflatable unit to deflate and disconnect plug from outlet.
3. After in-climate weather has passed, the unit may be re-inflated and wiped dry if necessary.

### **Setup Requirements:**

20' x 20' space is required (units reach a height of 16')

Level surface free of debris

Electrical Outlet within 50' of setup site

(\*Please let us know in advance if your set-up site requires more than 50' of cord)

### **Setup Information:**

For each inflatable unit rented Brady's Bouncers will provide a protective tarp, 4 sand bags to safely secure the unit down, one blower, one extension cord and one outlet surge protector. Brady's Bouncers will arrive 1 hour prior to your scheduled party or event and will give the Lessee a courtesy call when we are in route. Once setup is completed Brady's Bouncers will perform a walk around of the inflatable unit with the Lessee to review the Safety Rules and Regulations.

\*If the Lessee is unable to take part in the walk around, please designate an Individual to be present to do so, thank you from Brady's Bouncers!
